Please return this form along with the applicable registration fees. Students in the dance program are responsible for a \$50.00 registration fee; this includes the required leotard for class. Students that already have the required leotard are responsible for a \$35.00 registration fee. (Please see the dress code listed below.)

Class size: A minimum of five students is needed for a class, and no more than 16 will be admitted into a class. Registration is limited and is confirmed on a first-come, first-serve basis. No student will be added to a class roster without fees paid and registration forms complete.

Tuition payments: This contract guarantees a minimum of 32 scheduled lessons per season. For your convenience, tuition is paid in equal monthly installments due on the first class of each month regardless of calendar days, inclement weather or holiday closings. Tuition is not decreased for 3 week months nor is it increased for 5 week months. Payment is considered late after the 10th of the month and a \$10.00 late charge is added to all unpaid accounts. If a student needs to withdraw for any reason, a **30-day written notice will be required along with the following month's tuition paid.**

Costume fees: A 50% deposit for costumes is due with your October tuition and the balance is due with your November tuition. For each hour class this fee is \$57.00. For Ballet/Tap combination classes this fee is \$105.00, and for Ballet/Tap/Jazz classes this fee is \$155.00. Costume fees are non-refundable.

Recital: Our year-end recital is "KALEIDOSCOPE". Performance is part of learning and all Academy dancers must participate. There is a \$25.00 recital fee due with your April Tuition. Each family will receive two free tickets to the recital and additional tickets can be purchased at a minimal cost. The recital fee is used to rent the auditorium, hire a stage manager, technicians, etc.

Dress Code: All dance students are required to follow the Academy dress code.

Leotard: in the appropriate color for age (2-4=pink, 5-8=black, 8-12= green, 13 and up = purple)

Tights: Capezio style # 1816 in pink (tan tights are optional for jazz and tap classes)

Ballet Shoes: Revolution Dancewear Pink

Tap Shoes: Combo classes: Revolution Dancewear Tan / Leveled classes: Revolution Black Tap shoes

Jazz SHOES: Revolution dance wear tan jazz sandals and/or black slip on jazz shoes. See your teacher for specific jazz shoes.

Boys: White fitted tank or T-shirt, Black pants, Black jazz shoes (Revolution dance wear)

All tuition, costume, registration and recital fees are non-refundable for any reason.

There will be a twenty-five dollar (\$25.00) service charge for all returned checks for any reason.

In the event that any account is 60 days past due, that student will be dropped from the class roster unless prior arrangements have been made with the director.
